## PMCPOA CAMPGROUND RULES:

1. Facilities are available by reservation on a first come first serve basis.
2. Charges for camping are per campsite. A campsite unoccupied by a member must be charged at the guest rate. \$10.00 per night for members and \$15.00 per night for guests.
3. The number of guests per campsite shall be limited as prescribed by management.
4. The Maximum period of use is one week. This may be extended with approval from Management.
5. A receipt for use will be issued by the Business Office. A copy of this receipt must be posted on the campsite # at entrance to the campground.
6. Campers are not permitted to change campsites without prior approval from the Business Office.
7. **No Open Fires or Charcoal BBQs Permitted. Due to current conditions and restrictions placed by the National Forrest Service.**
8. Vehicular traffic including licensed motorbikes shall only be allowed on designated roadways and parking areas for means of entering and leaving only. No cruising.
9. Campsites shall be kept, and left, in a tidy and clean condition or the deposit may be forfeited.
10. Children under the age of 12 are to be under supervision of an adult at all times in the camp area.
11. No loud noise, including radios, etc., so as to disturb others, is permitted at any time. Generators can be used only from 7:00 a.m. to 10:00 p.m.
12. Pets are to be on a leash at all times.
13. Excessive use of alcohol or use of illegal drugs is prohibited.
14. Cutting or gathering of wood is strictly prohibited.
15. Generators can be used between the hours of 7am to 10pm daily
16. Firearms, peddling, or creating a public nuisance are not permitted.
17. PMC Patrol will patrol the campground and enforce these rules.
18. Please close the restroom doors securely! This is for your protection.
19. Dumping of holding tanks or wastewater is not permitted.
20. Check out time is 2:00 p.m.
